

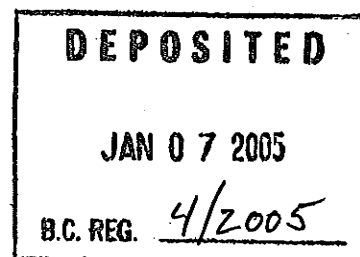

  - (c) *in the entries for* British Columbia Film Board, Committee on Public Participation in Science and Technology, Innovation and Science Council of British Columbia, International Financial Centre Vancouver Society, International Maritime Centre – Vancouver Society, Job Protection Commission, Minister's European Community Advisory Committee, Motor Dealer Customer Compensation Fund Board, North America Free Trade Advisory Committee, and TRIUMF-KAON Venture Office Advisory Board, *by striking out* "Minister of Competition, Science and Enterprise" *and substituting* "Minister of Small Business and Economic Development",
  - (d) *in the entries for* British Columbia Community Pride Program, British Columbia Sport and Recreation Advisory Council, British Columbia Summer and Winter Games Society, Pacific Rim Institute of Tourism, and Victoria Rediscovery Society, *by striking out* "Minister of Small Business, Tourism and Culture" *and substituting* "Minister of Small Business and Economic Development",
  - (e) *in the entries for* Building Safety Standards Advisory Council, Downtown Revitalization Program Society, and Plumbing Code Advisory Committee, *by striking out* "Minister of Municipal Affairs and Housing" *and substituting* "Minister of Community, Aboriginal and Women's Services",
  - (f) *in the entry for* Provincial Child Care Council *by striking out* "Minister of Community, Aboriginal and Women's Services" *and substituting* "Minister of Children and Family Development",
  - (g) *in the entry for* British Columbia Games Society *by striking out* "Minister of Community, Aboriginal and Women's Services" *and substituting* "Minister of Small Business and Economic Development",
  - (h) *in the entry for* British Columbia Safety Authority *by striking out* "Chair" *and substituting* "CEO",

- (i) *in the entry for Information Science and Technology Agency by striking out "Minister of Advanced Education, Training and Technology" and substituting "Minister of Management Services", and*
- (j) *in the entry for Medical Review Panels (Workers Compensation Act) (each panel) by striking out "Minister of Labour" and substituting "Minister of Skills Development and Labour".*
