 - (a) by repealing the definitions of "minister", "natural resources", "park officer", "park ranger", "park use permit", "recreation area" and "resource use permit", and
 - (b) by repealing the definition of "park" and substituting the following:"park" includes any land, trail, path or waterway comprised in an order under section 6 (1) (a) to (g) of the Act;.
- 2 Section 6 is repealed.
- 3 The following Division is added:

Division 9 – Park Rangers

Park ranger responsibilities

- The following enactments are prescribed for purposes of section 4 (3) (b) of the Act:
 - (a) regulations under the Ecological Reserve Act;
 - (b) sections 12 and 13 of the *Environmental Management Act*;
 - (c) section 9 of the Firearm Act;
 - (d) Liquor Control and Licensing Act;
 - (e) Motor Vehicle Act and regulations under that Act;
 - (f) Motor Vehicle (All Terrain) Act and regulations under that Act;
