

- 1** *Section 1 of the Forest Recreation Regulation, B.C. Reg 16/2004, is amended*
 - (a) by repealing the definition of “campground operator”,*
 - (b) by adding the following definitions:*
 - “recreation officer”** means an official designated for the purpose of this regulation;
 - “regional manager”** means an official designated as a regional manager for the purpose of this regulation;
 - “recreation site or trail operator”** means a person or class of persons authorized in writing under section 22 (6) to act as a recreation or trail operator; .
- 2** *Section 5 is amended*
 - (a) in subsection (1) by adding “by the minister or by a person designated in writing by the minister as authorized to conduct the review” **after** “refusal reviewed”, and*
 - (b) in subsection (2) by striking out “79,”.*
- 3** *Section 6 (4) is amended by adding “, a recreation officer” **after** “an official”.*
- 4** *Section 8 is amended by striking out “an official” and substituting “a recreation officer”.*
- 5** *Section 11 (2) is amended by striking out “an official” and substituting “a recreation officer”, and*
- 6** *Section 12 (2) is amended by adding “, a recreation officer” **after** “An official”.*
- 7** *Section 13 (1) is amended by striking out “an official” and substituting “a recreation officer”.*
- 8** *Section 14 is amended by striking out “an official” and substituting “a recreation officer”.*
- 9** *Section 15 is amended*
 - (a) in subsection (1) by striking out “an official” and substituting “a recreation officer”, and*
 - (b) in subsection (2) by striking out “An official” and substituting “A recreation officer”.*

- 10** *Section 16 is amended by striking out “an official” and substituting “a recreation officer”.*
