



- 2**     *Section 12 is amended*

  - (a) in paragraph (d) by striking out “27.3 (a);”,*
  - (b) in paragraph (e) by striking out “22.2 (3) (b) (i) or (ii); 26 (3) (b) or (c); 27.2 (6); 38 (2), (3), (4) or (5);” and substituting “22.2 (3) (b) (i); 26 (3) (a), (b) or (c); 38 (2), (3), (4) or (5); 39 (2);”, and*
  - (c) in paragraph (f) by striking out “22.3 (4); 27.3 (b);”.*
- 3**     *Section 14 is amended*

  - (a) in paragraph (a) by striking out “62 (2);” and substituting “62 (1) (b) or (2);”, and*
  - (b) in paragraph (e) by striking out “86 (3) (a), (b), (c), (d) or (e) or (4); 86.1 (3) (a); 87 (1), (2) or (3); 88 (1); 97.” and substituting “86 (3) (a), (b), (c), (d) or (e) or (6); 87 (1) or (3); 88 (1).”.*
- 4**     *Section 16 (e) is amended by adding “; 46 (a), (b) or (c).” at the end.*
- 5**     *Section 17 is amended*

  - (a) in paragraph (a) by striking out “4 (1) or (2);” and substituting “24 (1) or (2);”, and*
  - (b) in paragraph (e) by striking out “(a.1).”.*
- 6**     *Division 4 is repealed.*
