ADDITIONAL TAX REGULATION FOR THE CITY OF NORTH VANCOUVER AND THE DISTRICT OF NORTH VANCOUVER

Definition

1 In this regulation, "Act" means the Hotel Room Tax Act.

Applicability of additional tax

2 January 31, 2007 is the prescribed date after which section 3 of the Act applies in respect of accommodation purchased in the City of North Vancouver or the District of North Vancouver.

Prescribed rate of additional tax payable

The additional tax payable under section 3 (1) of the Act is 2% of the purchase price of accommodation purchased in the City of North Vancouver or the District of North Vancouver.

Prescribed purpose for expenditure of additional tax

The City of North Vancouver or the District of North Vancouver may spend the amount paid to it out of the revenue collected from the additional tax for tourism marketing, programs and projects.

Repeal

5 This regulation is repealed effective February 1, 2012.
