

APPENDIX

1 The Schedule to the Commercial Transport Fees Regulation, B.C. Reg. 328/91, is amended in item 3

(a) by striking out "TRAILER AND SEMI-TRAILER FEES" and substituting "GENERAL FEES", and

(b) by repealing paragraph (c) and substituting the following as indicated:

| | (v) For a duplicate of any permit issued under the Act | 18. |

2 The Schedule to the Motor Vehicle Fees Regulation, B.C. Reg. 334/91, is amended

(a) in subparagraph (i) in Column 1 of item 5 by striking out "Act," and substituting "Act, excluding a personalized number plate, an Olympic number plate and a number plate issued with a special licence," and

(b) by adding the following item as indicated:
