## SCHEDULE

- 1 Section 16 of the Hunting Regulation, B.C. Reg. 190/84, is amended**
  - (a) by repealing subsections (3.2) and (4) (g), and**
  - (b) in subsection (5) (a) by striking out “subsections (1), (3) or (3.2)” and substituting “subsection (1) or (3)”, and by striking out “subsection (1), (2.1), (3), (3.1) or (3.2).” and substituting “subsection (1), (2.1), (3) or (3.1).”**
- 2 Section 16.1 is amended**
  - (a) in subsection (1) (b) by striking out “in Region 4, 5 or 8”, and substituting “in Region 5 or 8”,**
  - (b) by repealing subsection (1) (c) and substituting “in Region 1, 2 or 4, a wolf”,**
  - (c) in subsection (1) (d) by striking out “in Regions 1 and 4” and substituting “in Region 1”, and**
  - (d) by repealing subsections (1) (g), (3) and (4).**
- 3 Section 19 (5) is amended**
  - (a) by adding the following:**

Epsom Park (M.U. 3-17)

Greenstone Mountain Park (M.U. 3-19),
  - (b) by striking out “Giscombe” and substituting “Giscome”,**
  - (c) by adding “Lakes” after “Heather-Dina”, and**
  - (d) by striking out “Nahatlach Protected Area” and substituting “Nahatlatch Protected Area”.**
- 4 Part 1 of Schedule 1 is repealed and the attached Part 1 of Schedule 1 is substituted.**
- 5 Part 2 of Schedule 1 is amended**
  - (a) by repealing section 1 (4),**
  - (b) in section 1 (6), (8), (12) and (14) by striking out “from September 10 to” and substituting “from the first Saturday after Labour Day to”,**
  - (c) in section 1 (12) by adding “south of the midline of North Gowland Harbour Road and Lakberg Road” after “On that portion on M.U. 1-15 known as Quadra Island”,**
  - (d) by adding the following section:**

#### **Youth season**

- 1.1** It is a condition of a hunting licence that the holder must not hunt antlerless mule (black-tailed) deer in M.U. 1-10 during the period September 8 to December 10, excepting bow only seasons, unless that holder is less than 19 years of age. ,
- (e) in section 4 (1) (a) and (c) and (3) by striking out "August 26 to September 8" and substituting "the fourth Saturday in August to the first Friday after Labour Day",*
- (f) in section 4 (1) (b) by striking out "August 26 to September 1" and substituting "August 26 to the Friday preceding Labour Day",*
- (g) in section 11 (2) by striking out "(September 15 to the Friday preceding Thanksgiving Day)" and substituting "(prior to the Saturday preceding Thanksgiving Day)",*
- (h) in section 11 (3) by striking out "from September 25 to the Friday preceding Thanksgiving Day" and substituting "for the 10 days starting with the Saturday preceding Thanksgiving Day" and by striking out "January 10 to January 25" and substituting "the 3rd Saturday in December to December 31" and by striking out "February 15 to March 10." and substituting "the 3rd Saturday in February to March 10.", and*
- (i) by repealing section 14 and substituting the following:*

#### **Waterfowler heritage days**

- 14** (1) In M.U.s 1-1 to 1-15, the open season for ducks, snow geese, Ross's geese and Canada geese is September 29 to September 30.
- (2) It is a condition of a hunting licence that the holder not hunt in the open season set out in subsection (1) unless that holder is less than 19 years of age.
- 6** *Part 1 of Schedule 2 is repealed and the attached Part 1 of Schedule 2 is substituted.*
- 7** *Part 2 of Schedule 2 is amended*
- (a) by repealing section 2.1 and substituting the following:*

#### **Youth Season**

- 2.1** It is a condition of a hunting licence that the holder not hunt antlerless mule (black-tailed) deer in M.U. 2-16 during the period October 21 to October 31, excepting bow only seasons, unless that holder is less than 19 years of age.
- (b) in section 7 by striking out "from the second" and substituting "from the third", and*
- (c) in section 9 (1) and (3) by striking out "September 30 to October 1," and substituting "September 29 to September 30" and in section 9 (2) by striking out "September 2 to September 3" and substituting "September 1 to September 2".*
- 8** *Section 4 of Part 3 of Schedule 2 is amended*
- (a) in subsection (1) by striking out "of the 10 geese",*

**(b) in subsection (2) by striking out “of the 20 geese”, and**

**(c) by adding the following subsections:**

- (3) For snow geese in M.U.s 2-4 and 2-5, the daily bag limit is 10 and is in addition to the Provincial bag limit of 5 geese, provided that no more than 10 of the geese are snow geese.
- (4) For snow geese in M.U.s 2-4 and 2-5, the possession limit is 20 and is in addition to the Provincial possession limit of 10 geese, provided that no more than 20 of the geese are snow geese.

**9 Part 1 of Schedule 3 is repealed and the attached Part 1 of Schedule 3 is substituted.**

**10 Part 2 of Schedule 3 is amended**

**(a) by repealing section 1 (6) and substituting the following:**

- (6) It is a condition of a hunting licence that the holder not hunt mule (black-tailed) deer bucks and white-tailed deer bucks in M.U.s 3-12 to 3-14, 3-17 to 3-31 and 3-34 to 3-44 during the period September 1 to September 9, excepting bow only seasons, unless that holder is less than 19 years of age., **and**

**(b) in section 7 (1) by striking out “September 2 to September 3.” and substituting “September 1 to September 2.”.**

**11 Part 1 of Schedule 4 is repealed and the attached part 1 of Schedule 4 is substituted.**

**12 Part 2 of Schedule 4 is amended**

**(a) by adding the following section:**

**Elk (antlerless)**

**2.1** (1) Despite Part 1 of Schedule 4, the open season for antlerless elk from September 10 to September 20 is restricted to the following zones as identified in Schedule II of the Limited Entry Hunting Regulation, B.C. Reg 134/93:

- (a) zone X of M.U.s 4-2 to 4-5;
- (b) zone X of M.U.s 4-20 to 4-22;
- (c) zone X of M.U. 4-26;
- (d) zone C of M.U.s 4-6 and 4-7;
- (e) zone C of M.U. 4-21.

(2) It is a condition of a hunting licence that the holder not hunt elk in the area described in subsection (1) during the period September 10 to September 20, excepting bow only seasons, unless the person is less than 19 years of age or 65 years of age or older.,

**(b) by repealing section 6 (2) and substituting the following:**

- (2) It is a condition of a hunting licence that the holder not hunt
  - (a) white-tailed deer bucks in M.U.s 4-1 to 4-9 and 4-14 to 4-40 during the period September 1 to September 9, unless the person is less than 19 years of age, or



- (b) antlerless white-tailed deer in M.U.s 4-1 to 4-9 and 4-14 to 4-40, during the period October 10 to October 20, excepting bow only seasons, unless the person is less than 19 years of age or 65 years of age or older. ,

**(c) by repealing section 8 (6), (8) and (9) and substituting the following:**

- (6) The open season for cougar in M.U.s 4-1 to 4-4, 4-21 to 4-26, 4-34 to 4-37 and 4-40 is the shorter of the following periods:
- (a) September 10, 2007 to February 28, 2008;
  - (b) September 10, 2007 until 72 hours after the regional manager has published that the total number of female cougar killed in M.U.s 4-1 to 4-4, 4-21 to 4-26, 4-34 to 4-37 and 4-40 since April 1, 2007 is 10.
- (8) The open season for cougar in M.U.s 4-9, 4-14 to 4-19, 4-27 to 4-33, 4-38 and 4-39 is the shorter of the following periods:
- (a) September 10, 2007 to February 28, 2008;
  - (b) September 10, 2007 until 72 hours after the regional manager has published that the total number of female cougar killed in M.U.s 4-9, 4-14 to 4-19, 4-27 to 4-33, 4-38 and 4-39 since April 1, 2007 is 10.
- (9) The open season for cougar in M.U.s 4-5 to 4-8 and 4-20 is the shorter of the following periods:
- (a) September 10, 2007 to February 28, 2008;
  - (b) September 10, 2007 until 72 hours after the regional manager has published that the total number of female cougar killed in M.U.s 4-5 to 4-8 and 4-20 since April 1, 2007 is 5. , **and**

**(d) in Section 19 by striking out "September 2 and 3." and substituting "September 1 and 2."**

**13 Part 3 of Schedule 4 is amended by repealing section 7 and substituting the following:**

**Cougar**

- 7** The bag limit for cougar is one.

**14 Part 1 of Schedule 5 is repealed and the attached Part 1 of Schedule 5 is substituted.**

**15 Part 2 of Schedule 5 is amended in section 13 by striking out "September 9 to September 10." and substituting "September 8 to September 9."**

**16 Section 2 of Part 3 of Schedule 5 is repealed.**

**17 Part 1 of Schedule 6 is amended by adding the following item:**

**(a) in section 3 (2) by striking out** “the westerly boundary of the watershed of Pike River; thence southerly along the westerly boundary of the watershed of Pike River to the point of intersection with a prolongation of the midline of Pike River; thence westerly and northerly along the said prolongation and the midline of Pike River to a point one km east of the natural boundary of Atlin Lake on the easterly shore thereof; thence northerly perpendicular from and parallel to the natural boundary of Atlin Lake at a distance of one km inland to the point of intersection with the midline of O’Donnel River; thence westerly along the midline of O’Donnel River and a prolongation thereof” **and substituting** “the eastern boundary of Atlin Park; thence westerly along the boundary of Atlin Park to its intersection with the natural boundary of Atlin Lake on the easterly shore thereof; thence westerly”,

**(b) by repealing section 3 (10) and substituting the following:**

(10) The open season for mountain goat in M.U. 6-14 from August 1 to February 28 is restricted to the area of 6-14 within the following described boundaries:

commencing at the intersection of Highway 37A and the eastern boundary of M.U. 6-14; thence southerly along the M.U. boundary to a point due east of the headwaters of the Marmot River; thence due west to the Marmot River; thence westerly along the Marmot River to the mean high water mark of Portland Canal; thence northerly along the easterly shore of Portland Canal to its intersection with the Bear River; thence northerly along the Bear River to its intersection with Highway 37A at Stewart; thence generally northerly and easterly to the point of commencement.,

**(c) by repealing section 11 (8) and substituting the following:**

(8) The open season described in subsection (7) is restricted to private property and Crown lands within 400 metres of private property, and a hunter must have permission of the landowner.

(8.1) It is a condition of a hunting licence that the holder not hunt antlerless mule (black-tailed) deer in that portion of M.U. 6-4 shown in map 6-11/05 during the period December 11 to December 31 unless that holder is less than 19 years of age.,

**(d) in section 14 (1) by striking out** “September 16 to September 17.” **and substituting** “September 15 to September 16.”,

**(e) in section 14 (1.1) by striking out** “6-1 to 6-30” **and substituting** “6-15 to 6-30”, **and**

**(f) by repealing section 17 and substituting the following:**

**Cougar**

**17** The open season for cougar in M.U.s 6-1 to 6-11 is the shorter of the following periods:

(a) September 10, 2007 to April 30, 2008;

(b) September 10, 2007 until 72 hours after the regional manager has published that the total number of female cougar killed in M.U.s 6-1 to 6-11 since April 1, 2007 is 5.

(7) It is a condition of a hunting licence that the holder not hunt antlerless mule (black-tailed) deer or antlerless white-tailed deer in M.U.s 7-2 to 7-18, 7-23 to 7-30 and 7-37 to 7-41 during the period September 10 to November 20, excepting bow only seasons, unless that holder is less than 19 years of age. ,

*(b) in section 2 (8) by striking out “and is restricted to persons less than 19 years of age”,*

*(c) in section 2 (9) by striking out “October 10 to October 31” and substituting “September 10 to October 5”,*

*(d) by adding the following section:*

**Youth Season**

**8.1** It is a condition of a hunting licence that the holder not hunt antlerless mule (black-tailed) deer and antlerless white-tailed deer in M.U.s 7-2 to 7-18, 7-23 to 7-30 and 7-37 to 7-41 during the period September 1 to September 9, unless that holder is less than 19 years of age. ,

*(e) by repealing section 26 (2),*

*(f) in section 27 (1) by striking out “, 7-21” and by striking out “October 4 to October 11.” and substituting “October 12 to October 25 and December 1 to December 20.”, and*

*(g) by repealing section 27 (2) and (3).*

**21 Part 3 of Schedule 7 is amended**

(1) The bag limit for mule (black-tailed) deer bucks is one.

- (b) *in section 10 (1) by striking out "September 2 to September 3." and substituting "September 1 to September 2."*
