

On the recommendation of the undersigned, the ~~Lieutenant Governor~~ by and with the advice and consent of the Executive Council, orders the Child Care Subsidy Regulation, B.C. Reg. 74/97, is amended

(a) in section 1 by adding the following definition:

“care surrounding school day” means the provision of care, before or after school hours, on days when school is in session, for children attending school, excluding kindergarten; ,

(b) by repealing section 4 (3),

(c) by repealing section 5 (a) (iii) and substituting the following:

(iii) is determined under the *Immigration and Refugee Protection Act* (Canada) to be a Convention refugee or a person in need of protection. ,

(d) in section 8 by adding the following subsection:

(1.1) If a parent is eligible for a subsidy for more than one type of child care set out in Schedule A, the minister may determine which subsidy rate applies. , and

(e) by repealing Schedule A and substituting the attached Schedule A.
