



    - (a.1) section 4.1 [application for income assistance - stage 1];*
    - (a.2) section 4.2 [application for income assistance - stage 2];,*
  - (c) in section 41 by striking out “section 4 (1) (a) or (b)” and substituting “section 4.1 (2) (a) (i) or 4.2 (3) (a)”;*
  - (d) in section 42.1 by striking out “section 4 (1) (d)” and substituting “section 4.2 (3) (c)”;*
  - (e) in section 52 (1) (a) (ii) by striking out “(h) (i), (iii) or (v)” and substituting “(h) (iii) or (v)”;*
  - (f) by repealing section 71 (3),*
  - (g) by repealing section 81 (1) (a), and*
  - (h) by repealing section 6 (d) of Schedule D.*
  
- 2** *The Employment and Assistance for Persons with Disabilities Regulation, B.C. Reg. 265/2002, is amended*
  - (a) by repealing section 4.3,*
  - (b) in section 36 by adding the following paragraphs:*
    - (a.1) section 4.1 [application for disability assistance - stage 1];*
    - (a.2) section 4.2 [application for disability assistance - stage 2];,*
  - (c) in section 37 by striking out “section 4 (1) (a) or (b)” and substituting “section 4.1 (2) (a) (i) or 4.2 (3) (a)”;*
  - (d) in section 38.1 by striking out “section 4 (1) (d)” and substituting “section 4.2 (3) (c)”;*
  - (e) by repealing section 65 (3),*
  - (f) by repealing section 73 (1) (a), and*
  - (g) by repealing section 6 (d) of Schedule D.*
