



On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders the following:

- 1 Effective November 30, 2007, the *Attorney General Statutes Amendment Act, 2007*, S.B.C. 2007, c. 14, is amended as set out in the attached Schedule.
- 2 Effective December 1, 2007, sections 69 to 132, 134, 136, 137 and 140 to 220 and Schedules 1 to 20 of the *Attorney General Statutes Amendment Act, 2007*, S.B.C. 2007, c. 14, are brought into force except item 73 of Schedule 15 insofar as it amends the following sections or other provisions of the *Securities Act*:
 - 140.1, in the definitions of "failure to make timely disclosure" and "management's discussion and analysis", as enacted by the *Securities Amendment Act, 2007*
 - 140.3 (4), as enacted by the *Securities Amendment Act, 2007*
 - 140.4 (8) (e) and (17), as enacted by the *Securities Amendment Act, 2007*
 - 140.5 (1) and (2), as enacted by the *Securities Amendment Act, 2007*
 - 141.2 (b), as enacted by the *Securities Amendment Act, 2007*.

- 1** *Sections 133, 135, 138 and 139 of the Attorney General Statutes Amendment Act, 2007, S.B.C. 2007, c. 14, are repealed.*
- 2** *Schedule 1 is amended*
 - (a) by repealing items 5, 10, 12, 22, 31, 51 and 63,*
 - (b) in Column 2 of item 11 by striking out "2 (1), in the definition of "charter", and*
 - (c) in Column 2 of item 48 by striking out "3 (b)" and "94, in the definition of "profession".*
- 3** *Item 13 of Schedule 4 is repealed.*
- 4** *Item 12 of Schedule 12 is amended in Column 2 by striking out "1 (1), in the definition of "plan" and "19.1 (a)".*
- 5** *Item 41 of Schedule 15 is amended in Column 2 by striking out "1 (1), in the definitions of "certificate", "driver's certificate" and "owner's certificate", "19.1 (a)", "30.1 (1), in the definition of "motor vehicle indebtedness", "38 (3) (b)" and "44.1 (4)".*
- 6** *Item 45 of Schedule 15 is amended in Column 2 by striking out "16 (1) (d), as enacted by S.B.C. 1999, c. 36, s. 9 (a)".*
