- 1 Sections 4 of the Gaming Control Regulations, B.C. Reg. 208/2002, is amended
 - (a) by repealing paragraph (b) and substituting the following:
 - (b) *lottery retailers*, comprised of persons that contract with the lottery corporation to
 - (i) sell lottery tickets as retailers, or
 - (ii) sell lottery tickets or provide other types of provincial gaming in the hospitality industry; , and
 - (b) by repealing paragraph (f).
- 2 Section 5 is amended
 - (a) by repealing subsection (1) (b) and substituting the following:
 - (b) lottery retailer employees, comprised of employees of lottery retailers, other than lottery retailer personnel described in subsection (2) (d);
 - (b) by repealing subsection (1) (f),
 - (c) in subsection (1) (g) by striking out "such as distributing bingo supplies and collecting money from players" and substituting "other than "gaming services" as defined in section 1 of the Act",
 - (d) by repealing subsection (1) (i),
 - (e) by repealing subsection (2) (d) and substituting the following:
 - (d) lottery retailer personnel, comprised of persons
 - (i) having on-site managerial responsibility at a retail or hospitality facility where lottery tickets are sold or other types of provincial gaming are provided, or
 - (ii) having managerial responsibility for a contract with the lottery corporation to sell lottery tickets or provide other types of provincial gaming., and
 - (f) in subsection (2) by adding the following paragraph:
 - (e) *lottery corporation employees*, comprised of all officials and employees of the lottery corporation; .
- 3 Section 27 is repealed and the following substituted:

Background investigation for personnel

- The following categories of persons are prescribed for the purposes of section 55 (b) of the Act:
 - (a) branch employees, comprised of all employees of the branch;

- (b) *lottery corporation employees*, comprised of all officials and employees of the lottery corporation.
- 4 Section 29 (2) is amended by repealing paragraphs (f) and (i) and substituting the following:
 - (f) lottery corporation employees, comprised of individuals who are officials or employees of the lottery corporation;
 - (i) lottery retailer personnel, comprised of persons
 - (i) having on-site managerial responsibility at a retail or hospitality facility where lottery tickets are sold or other types of provincial gaming are provided, or
 - (ii) having managerial responsibility for a contract with the lottery corporation to sell lottery tickets or provide other types of provincial gaming.
