*Health Authorities Act*

Ministerial Order No. M 158

I, George Abbott, Minister of Health, order that B.C. Reg. 293/2001, the Regional Health Boards Regulation, is amended

- (a) *in section 1 of Schedule B by striking out* “thence easterly along the southerly boundary of the Province of British Columbia to the westerly boundary of the watershed of Similkameen River being the point of commencement.” *and substituting* “thence easterly along the southerly boundary of the Province of British Columbia to the westerly boundary of the watershed of Similkameen River being the point of commencement. Saving and excepting the area outlined in bold black line on the explanatory plan attached as Schedule C.”,
- (b) *in section 5 of Schedule B by striking out* “thence east along the 53rd parallel of north latitude to its intersection with the 125th meridian of west longitude, being the point of commencement.” *and substituting* “thence east along the 53rd parallel of north latitude to its intersection with the 125th meridian of west longitude, being the point of commencement;

and

Thirdly, the area outlined in bold black line on the explanatory plan attached as Schedule C.”, *and*

- (c) *by adding the attached Schedule C.*

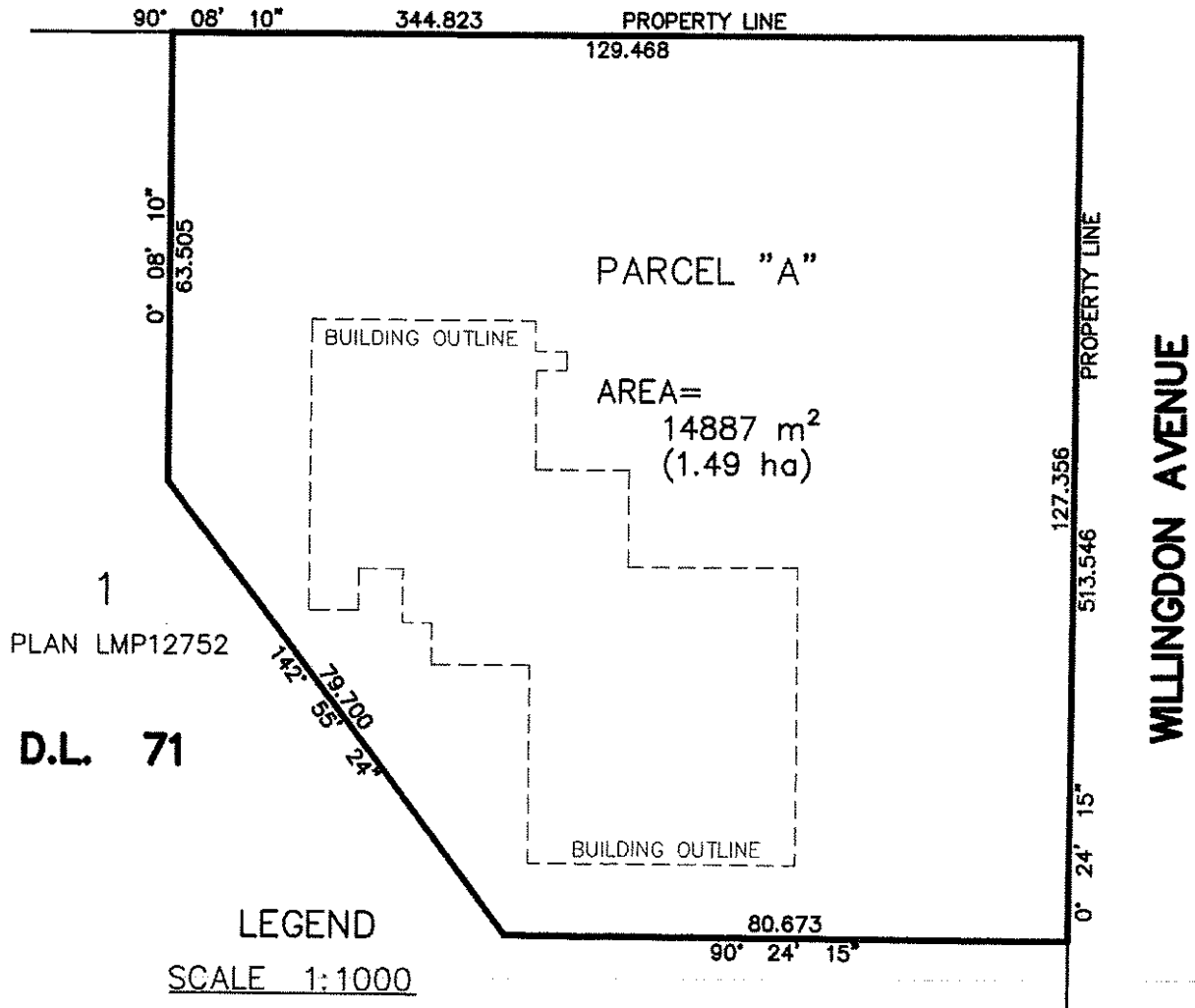
