 - (i) the Administrative Penalties (Environmental Management Act) Regulation, B.C. Reg. 133/2014;
 - (ii) the Contaminated Sites Regulation, B.C. Reg. 375/96;
 - (iii) the Municipal Wastewater Regulation, B.C. Reg. 87/2012;
 - (iv) the Open Burning Smoke Control Regulation, B.C. Reg. 152/2019;
 - (v) the Ozone Depleting Substances and Other Halocarbons Regulation, B.C. Reg. 387/99, and
- (b) effective August 1, 2026, the Administrative Penalties (*Environmental Management Act*) Regulation is amended as set out in the attached Appendix 2.

APPENDIX 1

Administrative Penalties (Environmental Management Act) Regulation

- 1 Section 23 of the Administrative Penalties (Environmental Management Act) Regulation, B.C. Reg. 133/2014, is amended by striking out "sections 3, 4, 5, 7 or 8 (2)" and substituting "section 2".
- **Section 33 (3) is amended by striking out "10 (3) or 27 (6)" and substituting "10 (3),** 12.1 or 27 (6)".

Contaminated Sites Regulation

- 3 Section 41 (4) (b) of the Contaminated Sites Regulation, B.C. Reg. 375/96, is amended by striking out "does not contain any substance" and substituting "does not contain any volatile substance".
- 4 Section 42 is amended
 - (a) by repealing subsection (2) (c) and substituting the following:
 - (c) the source site is being or has been used for the mining of marl, earth, soil, peat, sand, gravel, dimension stone, rock or any natural substance that is used for a construction purpose on land and the soil
 - (i) was extracted in accordance with a permit under the *Mines Act*, and
 - (ii) was not affected by a specified industrial or commercial use or another source of contamination; , and
 - (b) by adding the following subsection:
 - (2.1) Without limiting subsection (2), a removal of soil to a receiving site is exempt from section 55 (1.1) of the Act if all of the following circumstances apply:
 - (a) the source site is the subject of either
 - (i) a final determination under section 44 (2) (d) of the Act that the site is not a contaminated site, or
 - (ii) a certificate of compliance that the site has been remediated in accordance with the numerical standards referred to in section 53 (3) (a) (i) of the Act;
 - (b) the soil has not been contaminated since the final determination or certificate of compliance was issued;
 - (c) the soil, at any depth, and vapour at the source site does not contain any substance with a concentration greater than or equal to the numerical standard for the soil or vapour, respectively, that applies to the receiving site.
- 5 Schedules 8 and 8.1 are repealed and the attached Schedules 8 and 8.1 are substituted.

Municipal Wastewater Regulation

- 6 Section 1 of the Municipal Wastewater Regulation, B.C. Reg. 87/2012, is amended in the definition of "qualified professional" by striking out "technologist's" in both places and substituting "technologist's".
- 7 Section 86 is amended in Tables 6, 7 and 8 by striking out "nitrogen total, and nitrate (as N frequency and type)" and substituting "nitrogen total, and nitrate (as N) frequency and type".
- 8 Section 87 (3) is amended by striking out "gathered data under this section" and substituting "data gathered under section 86 and this section".
- 9 Section 103 is amended in Table 12 by striking out "ammonia frequency and type (freshwater)" and substituting "ammonia frequency and type (marine)".

Open Burning Smoke Control Regulation

- 10 Section 1 of the Open Burning Smoke Control Regulation, B.C. Reg. 152/2019, is amended by repealing the definition of "ventilation forecast" and substituting the following:
 - "ventilation forecast" means the most recent applicable ventilation index forecast issued by the ministry for a geographic area;
- 11 Sections 13 (2) (i) (i) (A), 19 (b) (i) (A), 20 (b) (i) (A), 21 (a) (i) (A), 22 (a) (i) (A), 23 (2) (e) (i) (A), 25 (2) (f) (i) (A) and 27 (c) (i) (A) are amended by striking out "a ventilation forecast for that area is obtained on the day, but before," and substituting "the most recent ventilation forecast for that area is obtained before".
- 12 Sections 21 (e) (i) and 27 (f) (i) are amended by striking out "a ventilation forecast or a custom ventilation forecast" and substituting "the most recent ventilation forecast, or an updated custom forecast,".
- 13 Section 23 (2) (a) (ii) is repealed and the following substituted:
 - (ii) for each site on which open burning is intended to be carried on, the location is described to a director by providing one or more of the following:
 - (A) the address, legal description, parcel identifier number (PID) or GPS coordinates of the site;
 - (B) a map that includes sufficient landmarks to ensure that the site is readily identifiable; .
- 14 Section 28 (5) (c) (i) (A) is amended by striking out "the ventilation forecast for that area is obtained on the day, but before," and substituting "the most recent ventilation forecast for that area is obtained before".

Ozone Depleting Substances and Other Halocarbons Regulation

- 15 Section 8 (b) of the Ozone Depleting Substances and Other Halocarbons Regulation, B.C. Reg. 387/99, is amended by striking out "maintain and make available for inspection by an officer during normal business hours at the business premises" and substituting "prepare and retain at the owner's normal place of business".
- **Section 9 (2) is amended by striking out** "and be available for inspection on request by an officer".
- 17 Section 10 (3) (b) is amended by striking out "be maintained and available for inspection on request by an officer" and substituting "be retained".
- 18 Section 12 (4) (c) is amended by striking out "provide for keeping records" and substituting "provide for preparing and retaining records".
- 19 The following section is added to Part 1:

Inspection of records

- **12.1** A person who must retain a record under section 8, 9, 10 or 12 must, on request of a director or officer and in accordance with that request, make the record available for inspection
 - (a) during normal business hours at the business premises, or
 - (b) electronically.
