### Remission

1 Authorization is given for the remission of the amount of the penalty imposed under section 11 (2) of the *Taxation (Rural Area) Act*, for the 2022 taxation year, on each owner in respect of the owner's property listed in the Schedule.

### Condition

- 2 The remission under section 1 is conditional on the payment in full, on or before December 31, 2022, in respect of the property, of
  - (a) the taxes referred to in section 11 (1) of the Taxation (Rural Area) Act, and
  - (b) any delinquent taxes.
