On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that, effective April 13, 2026,

- (a) the Gaming Control Act, S.B.C. 2022, c. 29, is brought into force,
- (b) the Gaming Control Regulation, B.C. Reg. 208/2002, is repealed,
- (c) the Frequency and Time of Payments of Horse Racing Betting Fees Regulation, B.C. Reg. 61/2003, is repealed,
- (d) the Gaming Services Registration Fee (Covid-19 Emergency) Remission Regulation, B.C. Reg. 95/2021, is repealed,
- (e) the Body Armour Control Regulation, B.C. Reg. 203/2010, is amended as set out in Schedule 1,
- (f) the Security Services Regulation, B.C. Reg. 207/2008, is amended as set out in Schedule 2, and
- (g) the Violation Ticket Administration and Fines Regulation, B.C. Reg. 89/97, is amended as set out in Schedule 3.
