- 1 Section 14.4 (c) of the Hunting Licensing Regulation, B.C. Reg. 8/99, is repealed.

 - (i) smaller than 20 gauge, or,
 - (b) by repealing paragraph (g) and substituting the following:
 - (g) small game, game birds, other than migratory game birds, lynx, bobcat, wolverine, mule (black-tailed) deer, white-tailed deer or fallow deer with a crossbow, other than a compound crossbow, having a draw weight of less than 55 kg,
 - (c) in paragraph (h) by striking out "or wolverine with a crossbow (except a compound crossbow)" and substituting "or wolverine, with a crossbow, other than a compound crossbow,",

- (d) in paragraph (h) (i) by striking out "pull" and substituting "draw weight",
- (e) in paragraph (i) by striking out "pull of less than 45 kg at full draw" and substituting "draw weight of less than 45 kg",
- (f) in paragraph (k) by striking out "pull of less than 18 kg within the archer's draw length" and substituting "draw weight of less than 18 kg",

 - (o) migratory game birds with
 - (i) a weapon other than a shotgun or a bow,

 - (vi) a crossbow
 - (A) having a draw weight of less than 45 kg, or
 - (B) using a bolt with a broadhead less than 22 mm at its widest point or less than 2 sharp blades,,
- (h) in paragraph (r) (ii) by striking out "pull greater than 22.6 kg within the archer's draw length" and substituting "draw weight greater than 22.6 kg", and
- (i) in paragraph (u) by striking out "other than bison, caribou, elk, grizzly bear, moose, mountain sheep or mountain goat" and substituting ", other than bison, caribou, elk, grizzly bear, moose, mountain sheep or mountain goat,".
