 - (a) by repealing paragraph (a) and substituting the following:
 - (a) in Region 1 or 2 or M.U. 4-8, 4-9, 4-14 to 4-19, 4-27 to 4-33, 4-37, 4-38, 5-2, 6-1, 6-2, 6-4 to 6-6, 6-8 or 6-9, an elk,
 - (b) by repealing paragraph (g) and substituting the following:
 - (g) in M.U. 6-1 to 6-11, 6-15 or 6-17 to 6-30 or that portion of M.U. 7-52 outlined in red on map '2022 M.U. 7-52 Moose Compulsory Inspection', a moose, or , *and*
 - (c) by repealing paragraphs (g.1), (h) and (i).
- 2 Section 16 (4) (b) is amended by striking out ", a lynx, a bobcat".
- 3 Part 1 of Schedule 4 is amended
 - (a) by adding the following item as indicated:

4 Part 3 of Schedule 4 is amended by adding the following section:

Deer - special open seasons

- **1.1** (1) In this section, **"special open seasons"** means the January 5 to January 31 open seasons for deer in those portions of M.U.s 4-3 to 4-5 and 4-20 shown on map '2025 Mule Deer & White-Tail Deer Cranbrook General Open Season'.
 - (2) The aggregate bag limit for deer taken during the special open seasons is one.
 - (3) The other bag limits for deer in Region 4 are modified as follows:
 - (a) a deer taken during the special open seasons is not to be counted against the bag limits set under section 1;
 - (b) the limit of one mule (black-tailed) deer buck set out in section 11 (1) (a) of the regulation does not apply in relation to a deer taken during the special open seasons.
