SCHEDULE 1

- 1 Section 3 of the Laboratory Services Regulation, B.C. Reg. 52/2015, is amended
 - (a) in subsection (1) (d) by striking out ", "nurse practitioner" or "registered nurse practitioner", and
 - (b) by repealing subsection (2) and substituting the following:
 - (2) A health care practitioner is prescribed as a referring practitioner for the purposes of the Act if the health care practitioner is a registrant of the British Columbia College of Nurses and Midwives who
 - (a) is authorized to use the title "nurse practitioner", or
 - (b) is authorized to use the title "registered nurse" or "registered psychiatric nurse", and
 - (i) is a certified practice registrant within the meaning of the Nurses (Registered) and Nurse Practitioners Regulation, or
 - (ii) makes a request for a beneficiary to receive benefits in relation to communicable disease prevention and management.
- 2 Section 3.1 is repealed.
- 3 Section 6 is repealed and the following substituted:

Prescribed agency

6 For the purposes of the definition of "prescribed agency" in section 1 of the Act, the Provincial Health Services Authority is prescribed.

- 1 Section 45 of the Medical and Health Care Services Regulation, B.C. Reg. 426/97, is amended
 - (a) by repealing subsection (1) and substituting the following:
 - (1) In this section, "RN (certified) or RPN (certified)" means either of the following who is a certified practice registrant within the meaning of the Nurses (Registered) and Nurse Practitioners Regulation:
 - (a) a registered nurse;
 - (b) a registered psychiatric nurse., and
 - (b) by repealing the table to subsection (2) and substituting the following:

1	Enrolled medical practitioner	All diagnostic services
2	Nurse practitioner	Those diagnostic services associated with the scope of practice of a nurse practitioner

3	RN (certified) or RPN (certified)	Those diagnostic services associated with the scope of practice of a RN (certified) or RPN (certified), if requested without an order having been made by a practitioner referred to in any of items 1, 2, 4, 5 or 6
4	Enrolled dentist	Those diagnostic services associated with the scope of practice of a dentist
5	Enrolled podiatrist	Those diagnostic services associated with the scope of practice of a podiatrist
6	Enrolled midwife	Those diagnostic services associated with the scope of practice of a midwife
