Employment and Assistance Regulation

1 Section 10 (a) (ii) of Schedule C of the Employment and Assistance Regulation, B.C. Reg. 263/2002, is amended by striking out "through the mother's breast milk" and substituting "through the breast milk of the dependent child's parent".

Employment and Assistance for Persons with Disabilities Regulation

1 Section 9 (a) (ii) of Schedule C of the Employment and Assistance for Persons with Disabilities Regulation, B.C. Reg. 265/2002, is amended by striking out "through the mother's breast milk" and substituting "through the breast milk of the dependent child's parent".

Expropriation Act General Regulation

1 Section 4 (2) and (3) of the Expropriation Act General Regulation, B.C. Reg. 451/87, is amended by striking out "his security interest" and substituting "the security holder's security interest".

Family Law Act Regulation

1 Form 5 of the Family Law Act Regulation, B.C. Reg. 347/2012, is amended by striking out "Gender: M[] F[]" and substituting "Gender:".

Hospital Insurance Act Regulations

1 Section 5.22 (d) of the Hospital Insurance Act Regulations, B.C. Reg. 25/61, is amended by striking out "male or female,".

Medical and Health Care Services Regulation

- 1 Section 29 (1) of the Medical and Health Care Services Regulation, B.C. Reg. 426/97, is repealed and the following substituted:
 - (1) Services are not benefits if they are provided by a health care practitioner to the following members of the health care practitioner's family:
 - (a) a spouse;
 - (b) a child or step-child;
 - (c) a parent or step-parent, or a parent of a spouse;
 - (d) a grandparent or grandchild;
 - (e) a sibling;
 - (f) a spouse of a person referred to in paragraphs (b) to (e).

- 2 Section 38 (4) (c) is repealed and the following substituted:
 - (c) a material financial interest in the diagnostic facility is held by any of the following members of the practitioner's family, and the practitioner is aware of the financial interest:
 - (i) a spouse;
 - (ii) a child or step-child;
 - (iii) a parent or step-parent, or a parent of a spouse;
 - (iv) a grandparent or grandchild;
 - (v) a sibling;
 - (vi) a spouse of a person referred to in subparagraphs (ii) to (v), .

Milk Industry Standards Regulation

1 Section 85 (3) of the Milk Industry Standards Regulation, B.C. Reg. 464/81, is amended by striking out "male and female".

Vital Statistics Act Regulation

- Section 1 (2) of the Vital Statistics Act Regulation, B.C. Reg. 69/82, is amended by striking out "A reference in this regulation to "parent", "guardian", "mother", "father", "sister" or "brother" is a reference to the parent, guardian, mother, father, sister or brother of the person" and substituting "A reference in this regulation to "parent", "guardian" or "sibling" is a reference to the parent, guardian or sibling of the person".
- 2 Sections 2 (1) (b) and 5 (1) (b) are amended by striking out "sister or brother" and substituting "sibling".
