## **SCHEDULE**

- 1 Order in Council 596/2024 is amended in Appendix A by adding the following sections:
  - **4.1** The duties, powers and functions of the Minister of Public Safety and Solicitor General respecting the development of policy and legislation regarding consumer protection, and respecting the oversight of delegated consumer protection authorities are transferred to the Attorney General and Deputy Premier.
  - 24.1 The duties, powers and functions of the following Ministers respecting capital expenditure for non-major capital projects of the agencies and entities in the education, child care, health and post-secondary sectors for which the Ministers are responsible, in relation to policy development, planning, capital funding, land acquisition, development and administration of surplus land, procurement, delivery and oversight are transferred to the Minister of Infrastructure:
    - (a) the Minister of Education and Child Care;
    - (b) the Minister of Health;
    - (c) the Minister of Post-Secondary Education and Future Skills.
