- (c) the Wildlife Act General Regulation, B.C. Reg. 340/82, is amended as set out in the attached Appendix 3.

## **APPENDIX 1**

- 1** *Section 5 (3) of Part 2 of Schedule 4 of the Hunting Regulation, B.C. Reg. 190/84, is amended by striking out “September 30” and substituting “November 30”.*
- 2** *Section 1 of Part 2 of Schedule 5 is amended by adding the following subsections:*
  - (13) Except as permitted under the Limited Entry Hunting Regulation (B.C. Reg. 134/93), for the purpose of section 26 (1) (c) of the Act there is no open season on mountain goat in Zone A of 5-15, as shown on map ‘2025 Mountain Goat Zone A of 5-15’.
  - (14) Except as permitted under the Limited Entry Hunting Regulation (B.C. Reg. 134/93), for the purpose of section 26 (1) (c) of the Act there is no open season on mountain goat in Zone B of 5-15, as shown on map ‘2025 Mountain Goat Zone B of 5-15’.
- 3** *Section 6 (4) of Part 2 of Schedule 6 is amended*
  - (a) by adding the following paragraphs:*
    - (a.1) Zone A of M.U. 6-19, as shown on map ‘2018/2019 Moose Zone A of 619’;
    - (a.2) Zone A of M.U. 6-20, as shown on map ‘2010/2011 Moose Zone A of 620’;
    - (a.3) Zone B of M.U. 6-20, as shown on map ‘2018/2019 Moose Zone B of 620’; , and
  - (b) by repealing paragraph (l).*

## **APPENDIX 2**

- 1** *Schedule II of the Limited Entry Hunting Regulation, B.C. Reg. 134/93, is amended*
  - (a) by repealing the map “Mtn Goat Map 13/23”, and*
  - (b) by adding the following maps:*
    - 2025 Mountain Goat Zone A of 5-15
    - 2025 Mountain Goat Zone B of 5-15 .

## **APPENDIX 3**

- 1** *Section 4.08 of the Wildlife Act General Regulation, B.C. Reg. 340/82, is repealed and the following substituted:*

### **Transport of animal parts outside CWD management zone**

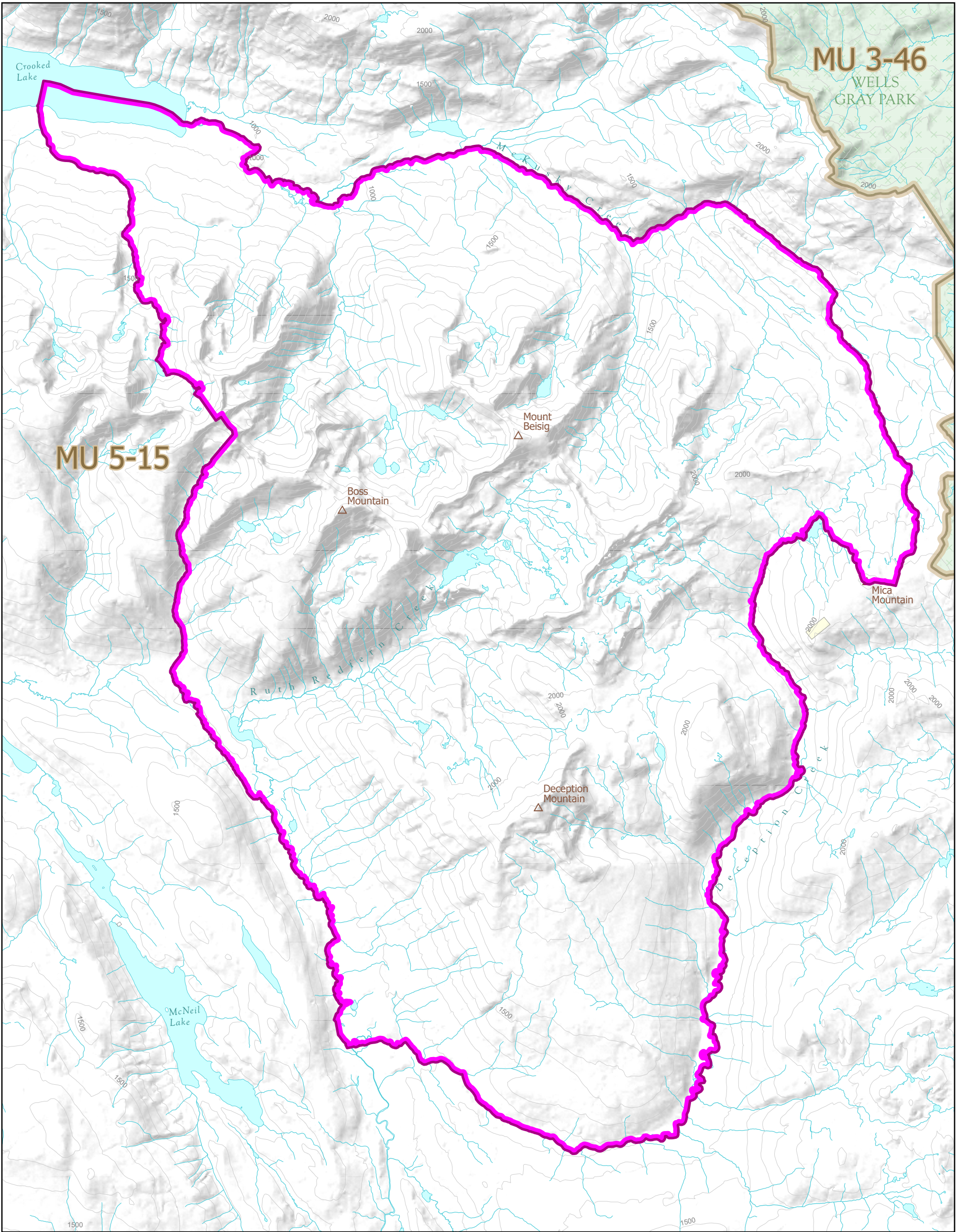
- 4.08** (1) In this section, “CWD management zone” means M.U.s 4-1 to 4-8 and 4-20 to 4-25.

- (2) Subject to subsection (3), a person who takes or kills a deer, elk or moose within the CWD management zone must not ship or transport, or engage another person to ship or transport, the following parts of the animal outside of that zone:
- (a) brain tissue;
  - (b) the spinal column, including the vertebrae and central nervous system tissue but not including the tail.
- (3) Subsection (2) does not apply in relation to a part of an animal that is taken or killed under a licence that includes a condition requiring the part to be deposited at a drop-off location if
- (a) the site where the animal is taken or killed is in a management unit set out in Column 1 of the Table and the drop-off location nearest to that site is set out in Column 2 opposite, and
  - (b) the part is shipped or transported directly to that drop-off location by the route set out in Column 3 opposite and deposited there within 24 hours after the animal is taken or killed.

1	M.U. 4-7	Nelson	through M.U. 4-18 on the Harrop cable ferry, Harrop Ferry Road and Highway 3A
2	M.U. 4-8	Nelson	through M.U. 4-16, 4-17 and 4-18 on the Glade cable ferry, Glade Ferry Road and Highway 3A / Highway 6
3	M.U. 4-8	Fruitvale	through M.U. 4-16 on Highway 3A
4	M.U. 4-25	Invermere	through M.U. 4-26
5	M.U. 4-25	Canal Flats	through M.U. 4-26 on Highway 93 / Highway 95



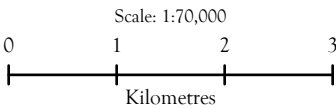

Zone A of 5-15

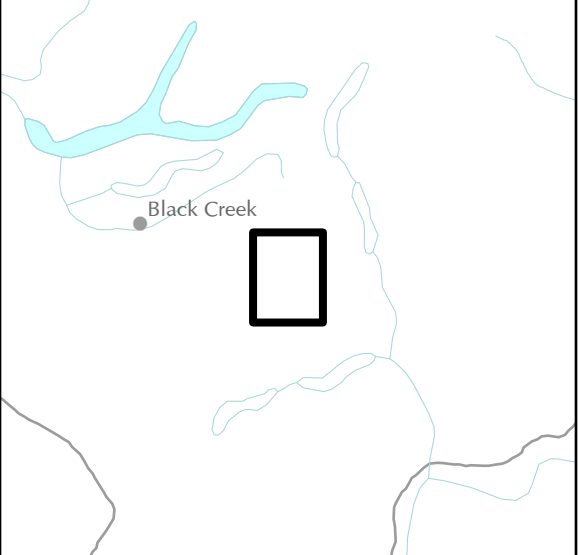

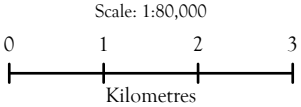
