

ORDER OF THE LIEUTENANT GOVERNOR IN COUNCIL

Order in Council No. 392

On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that, effective July 15, 2023,

- (a) section 70 of the *Forest Amendment Act, 2021*, S.B.C. 2021, c. 38, is brought into force,
- (b) the Advertising, Deposits, Disposition and Extension Regulation, B.C. Reg. 55/2006, is amended as set out in the attached Schedule 1,
- (c) Part 2 of the Community Tenures Regulation, B.C. Reg. 352/2004, is repealed,
- (d) section 5 (1) (b) of the Disposition and Change of Control Regulation, B.C. Reg. 351/2004, is repealed,
- (e) the Forest Planning and Practices Regulation, B.C. Reg. 14/2004, is amended as set out in the attached Schedule 2, and
- (f) Item 6 in Schedule 1 of the Integrated Land and Resource Registry Regulation, B.C. Reg. 180/2007, is repealed.

- 2 Sections 8 (1), 12 (1) and (2) (a) and 13 (1) are amended by striking out “tree farm licence, community salvage licence, woodlot licence” and substituting “tree farm licence, woodlot licence”.**

- 1 Sections 19.1 (b), 33 (1) (c) and 46.1 of the Forest Planning and Practices Regulation, B.C. Reg. 14/2004, are repealed.**
- 2 Section 46.11 (1) (a) is amended by striking out “section 44, 46.1 or 46.2 (5)” and substituting “section 44 or 46.2 (5)”.**
- 3 Section 46.2 (1) (a) and (b) is amended by striking out “section 44 to 46.1” and substituting “sections 44 to 46”.**
- 4 Section 91 (1) (a) (ii) is amended by striking out “46.1;”.**
- 5 Section 94 (6) is repealed and the following substituted:**
 - (6) In fulfilling an obligation transferred under section 29.1 of the Act to a person, the person must comply with the following provisions of this regulation:
 - (a) sections 42 to 46, as applicable;
 - (b) sections 58, 63, 86 (3) (b) to (d), 87 (3) and 88;
 - (c) every other provision of this regulation that regulates silviculture treatments, either specifically or by reference to a primary forest activity.
- 6 Section 96 (1) is amended by striking out “46, 46.1 or 74” and substituting “46 or 74”.**
- 7 Section 97 is amended**
 - (a) in subsection (3) by striking out “or 46.1 (2)”, and**

- 8 Section 97.1 (1) (a) is amended by striking out “44, 46.1 or 46.2 (5)” and substituting “44 or 46.2 (5)”.**
