- (c) the British Columbia College of Oral Health Professionals, but only with respect to health care professionals who are authorized to use the title "dentist"; .

- 1 Section 1 of Schedule C of the Employment and Assistance Regulation, B.C. Reg. 263/2002, is amended**
- (a) **in the definition of "dental hygienist" by striking out "College of Dental Hygienists established under the Health Professions Act" and substituting "British Columbia College of Oral Health Professionals",**
 - (b) **in the definition of "dentist" by striking out "College of Dental Surgeons of British Columbia continued under the Health Professions Act" and substituting "British Columbia College of Oral Health Professionals", and**
 - (c) **in the definition of "denturist" by striking out "College of Denturists of British Columbia established under the Health Professions Act" and substituting "British Columbia College of Oral Health Professionals".**

SCHEDULE 3

- 1 Section 1 of Schedule C of the Employment and Assistance for Persons with Disabilities Regulation, B.C. Reg. 265/2002, is amended**
- (a) **in the definition of "dental hygienist" by striking out "College of Dental Hygienists established under the Health Professions Act" and substituting "British Columbia College of Oral Health Professionals",**
 - (b) **in the definition of "dentist" by striking out "College of Dental Surgeons of British Columbia continued under the Health Professions Act" and substituting "British Columbia College of Oral Health Professionals", and**
 - (c) **in the definition of "denturist" by striking out "College of Denturists of British Columbia established under the Health Professions Act" and substituting "British Columbia College of Oral Health Professionals".**

SCHEDULE 4

- 1 Section 31 (e) of the Employment Standards Regulation, B.C. Reg. 396/95, is repealed and the following substituted:**
- (e) a registrant of the British Columbia College of Oral Health Professionals who is authorized to use the title “dentist”, “dental surgeon”, “surgeon” or “doctor”, .

SCHEDULE 5

- 1 Section 7 of the Hospital Act Regulation, B.C. Reg. 121/97, is amended**
- (a) by repealing subsection (1) (a) (i.1) and substituting the following:**
 - (i.1) practise a profession regulated by the British Columbia College of Oral Health Professionals and to use the title “dentist”, “dental surgeon”, “surgeon”, “doctor” or “dental therapist”, or ,
 - (b) by repealing subsection (4) (a.1) and substituting the following:**
 - (a.1) the British Columbia College of Oral Health Professionals, or , **and**
 - (c) in subsection (6) (b) by striking out “College of Dental Surgeons of British Columbia” in both places and substituting “British Columbia College of Oral Health Professionals”.**
- 2 Section 15 (2) is amended by striking out “College of Dental Surgeons of British Columbia” and substituting “British Columbia College of Oral Health Professionals”.**

SCHEDULE 6

- 1 Section 3 (2) (h) (v) of the Information Regulation, B.C. Reg. 208/2010, is repealed and the following substituted:**
- (v) the British Columbia College of Oral Health Professionals, if the registrant is, or the former registrant was, authorized to use the title “dentist”, “dental surgeon”, “surgeon”, “doctor” or “dental therapist”;

 - (c) surgeon;
 - (d) doctor;
 - (e) dental therapist;
 - (f) dental hygienist;
 - (g) denturist.
